LifeScape Ambassadors:

Celebrating 70 Years of Making a Difference

Seventy years ago--right about now--a few women were busy creating a homey atmosphere for children about to move into "Crippled Children's Hospital & School" in Sioux Falls. The new facility was built entirely through private donations on donated land so kids could go to school while recovering from the paralysis-causing polio virus. There were no laws requiring schools or any public spaces to be accessible for wheelchairs, so returning to their home schools wasn't an option for many kids recovering from polio.

Meanwhile, across town, another auxiliary began to support youngsters with developmental disabilities served by Sioux Vocational School & Hospital for the Handicapped – later to become South Dakota Achieve. Organizer Val Beckman served as the first president from 1968 to 1970.

Auxiliary. As a student nurse from 1950 to 1953, Phyllis had cared for young polio patients at Sioux Valley Hospital, including those in iron lungs. "I remember the power failing a couple of times and having to hand-pump an iron lung to keep the motor going," she says. "Fortunately, the fire department showed up fast to take over until they could get the power back on."

During the 1971-1972 program year, Phyllis Joyce joined the Sioux Vocational

Bridge luncheons with a style show were their main fundraiser. "The staff would roast turkeys, and auxiliary members would pick the meat off the bones to make turkey salad for the luncheon. The style show was put on by a dress shop at Park Ridge." The group volunteered with adults at Sioux Vocational, helping them in their workshops. They also provided funding for things like winter coats, bus tickets, dances, and parties.

In 2014, when South Dakota Achieve and Children's Care Hospital & School affiliated, the two auxiliaries merged and became the LifeScape Ambassadors. It wasn't easy at first. The two groups were used to being dedicated to the very different needs of adults or children. The group has melded, though, and new members have joined, including some men. Wish List purchases, from funds raised through Mall Walk (started in 1994) and other fundraisers, provide needed items for adults and children—including outpatients in Rapid City and Sioux City. Last year, the Ambassadors gave \$107,858 in Wish List grants, from rent assistance for adults to therapy and educational needs for children, to medical equipment for all ages.

Phyllis Joyce is still active today as a LifeScape Ambassador – maybe the longest currently active member at fifty years. She helps adults with their lunch each Wednesday and does sewing and mending when needed. She is there for the monthly meetings to learn more about the organization and trends in disability services. It's a part of her life, and we are lucky for her and the other Ambassadors who are so dedicated to our mission.

As the group marks 70 years of making a difference for children and adults with disabilities, it's hard to fathom where LifeScape would be without them. They truly provide the extras that set us apart in service excellence. And it was all a grass-roots effort, the way the best organizations are. Here's to many more years of the LifeScape Ambassadors!

From Our Chief Executive Officer

It is that time of year again when LifeScape approaches the South Dakota Legislature for additional funding needs. Last year was successful in part due to all of your THANK YOU! It really mattered and it was a critical part of our success, which led to \$3 per hour increases to our front-line support team. This has allowed us to better stabilize our staffing and provide better support to our LifeScape family. Staff wages start at \$12.50/ hour and average \$15.09/hour for DSPs.

We have three asks this legislative session:

- **1.** A summer rate review for our adult support services suggests a 14.5% increase in rates over-and-above the funding we received last year. The last time a rate review was completed was ir 2001! We are asking the legislature to fully fund this increase to ensure proper adult care and allow us to start addressing our waitlist of 53 families.
- 2. We are asking the legislature for \$3 million in additional funding for our children's 24/7 residential care. This again goes directly to our front-line staff that support our children in residential care who have substantial behavioral and medical needs. Due to staffing concerns we are providing care for 12 fewer children than we would normally be caring for, and we have 23 families on our waitlist for these services.
- 3. Lastly, we are asking the legislature to consider contributing \$16 million in one-time federal funds towards a new children's campus project. I estimate that there is \$1.8 billion in one-time funds the State will be handing out this legislative session. The work we do is really a sub-contract of the State's obligation to provide Medicaid services to the children of South Dakota. Even though we supported over 3,000 children last year, we have substantial waitlists in all services. A new campus would allow us to address those unserved populations.

I would ask that you reach out to your local state legislators and ask them to support the request of Community Support Providers for a 14.5% increase based on the rate work done this summer, \$3 million in funding for LifeScape's children's residential program, and \$16M in onetime funding for the new children's campus. Any personal note that you can add to that request is incredibly appreciated!!!

Lloyd Companies has supported LifeScape in various ways for nearly two decades. Through their affordable housing division, they are continuing their partnership with LifeScape to build a series of customized duplexes for adults with disabilities. The first, the Continuum Home, was a firstof-its-kind dwelling for young adults transitioning from children's services to more independent living as adults. It opened in February 2021.

Since then, Lloyd Companies and LifeScape have built a similar 5,378 square foot twin

home which opens for adults in February 2022. The partnership is part of a major initiative to build five new ADA-compliant homes in five years. The units are designed for eight residents.

Finding residential lots to build on in Sioux Falls is challenging, but especially so for our twin home projects, as they take twice the space of a single-family home. Lloyd Companies has helped LifeScape scout properties that accommodate the footprint and are affordable. The goal is to have the homes blend into their neighborhoods. The residents and their families are thrilled with the homes, which provide plenty of privacy, but good common areas for camaraderie and socializing.

"We feel blessed to be working with such an amazing organization," says Chris Thorkelson, Lloyd Companies President and CEO. "We are truly grateful for what Lifescape does in our community and throughout the region."

Lloyd Companies was founded in 1972 by Craig and Pat Lloyd. The Sioux Falls-based company now includes development, real estate, construction, property management and hospitality services, with locations also in Rapid City and Des Moines. As they celebrate their 50th anniversary this year, we thank them for the excellent partnership that is helping provide dream homes for adults supported by LifeScape!

I grew up on a farm near Dell Rapids and spent the first 25 years of my married life farming with my wife, Judi. Together we raised six boys and one girl. The farm was a great place to raise our children. We experienced many blessings on their journeys to adulthood—going on to the military, higher education, careers, and good marriages. We also fulfilled Judi's dream of being foster parents for several years.

After our move into town, I saw a newspaper ad that grabbed my attention: "How would you like to make a difference in the lives of others?" After touring LifeScape (then Sioux Vocational Services), I applied for and got a job as a work supervisor with adults.

This opened a new world for me. I was in awe observing staff completely focused on assisting people in learning new tasks. They were very proud of what they could do, and it caused so much happiness and desire to learn more difficult things. I learned that those with disabilities have many abilities with the right training and encouragement. Every day was a new experience, and I was greeted at the door with news from their homes, their concerns, and requests for the upcoming day.

They were curious about where I lived and wanted to meet Judi. So, each week, two people from day services would come home with me to see my town, my house, and meet Judi, who would have a delicious meal ready for us. Things like this made such an impact on their lives, and we felt so much fulfillment in providing that love and enjoyment. Some wanted to visit yearly, so we hosted group picnics in our back yard twice each summer so all could come at least once. We also volunteered at "Trent Farm" each summer, which is dedicated to enriching the lives of those with disabilities. Every Wednesday all summer, volunteers give wagon rides in pastures to feed corn to cows, help people drive a tractor, ride a horse, fish in a small lake, and enjoy a picnic lunch followed by a singalong.

LifeScape's "Linden Home" is the second new-construction home built in partnership with the South Dakota Housing Development Authority. It will open in early 2022. A third home, Magnolia, is set to break ground in spring 2022. The homes are part of LifeScape's "Five Years, Five New Homes" initiative to improve the quality of life for adults receiving residential services. Several existing homes are being refurbished as well.



Hamsters USA: Champions of West River Children with Disabilities

Hamsters USA, the longtime friends of children's services at LifeScape Rapid City, blew their already amazing philanthropic giving out of the water at their annual meeting in August 2021.

The group meets during the Sturgis Rally, and for the last 17 years, has hosted a silent and live auction for LifeScape at their banquet. These events have typically raised an amazing amount of money at the one-night event – usually around \$250,000. This past year, though, they came together to raise an unprecedented \$550,957, which all stays local to support children with disabilities in western South Dakota!

Inspired by seven-year-old Ruby Lehmann, who spoke on stage with her mom, Shannon, and her brother, David, Hamsters USA stepped up to do more than ever! Hamsters stormed the stage to give cash and credit card pledges, which were matched by members John McCarthy and Bobby Garone. That segment of the evening raised approximately \$204,000 alone!

Over the past 17 years, Hamsters USA has raised \$4 million to support LifeScape's services to children in western South Dakota. Their gifts help provide services to children at our clinic in Rapid City, as well as directly to kids in their Black Hills area homes and schools. Outreach therapies are delivered by LifeScape personnel who drive over 10,000 miles a month to provide services.

Ruby was diagnosed at nine months old with spastic diplegic cerebral palsy after her parents noticed she wasn't meeting typical milestones. Doctors believe Ruby had a stroke in utero early in her development, which prevented part of her brain from fully forming. It affected three-fourths of her body – her entire left side and her right leg. She began physical and occupational therapy at 10 months, and at the age of three, began speech therapy, primarily for a gag reflex. RISE Custom Solutions, a subsidiary of LifeScape, has fitted her for foot orthotics, a reverse walker, and wheelchair.

She now receives physical and occupational therapies at school and through LifeScape. Ruby's mom is so grateful for LifeScape, and for donors like Hamsters USA that make sure the high-quality services are available to families like theirs. "I will do anything and everything possible to make sure she is the best she can be," says Shannon.

Jessica Wells, President of the LifeScape Foundation, added, "We are just completely blown away by these incredible men. Our services would look very different were it not for them."








2021 LifeScape Audited Revenues Total: \$75,540,121




2021 LifeScape Audited Expenses Total: \$65,652,853

Of the total expenses, \$2,381,608 is a distribution to the service provider LifeScape. This amount is determined by the LifeScape Foundation's spending policy of distributing 4% of the 16-quarter rolling average of the endowment's market value. The policy protects the endowment from inflation, provides for endowment growth, and makes possible a distribution amount for program support.

An additional \$622,714 in donor-designated support and \$901,200 in adult housing construction grants were provided to LifeScape.


